She argues that Plato presents the philosopher and the sophist as difficult to distinguish, insofar as both use rhetoric as part of their arguments. Plato does not present philosophy as rhetoric-free, but rather shows that rhetoric is an integral part of the practice of philosophy.

Plato's conception of rhetoric however changes in the Phaedrus. Within the text, Plato differentiates true rhetoric from false rhetoric. He argues that it is not necessarily the practice of rhetoric which is bad but it is the practice of rhetoric shamefully or badly which leads to the art's denunciation (Phaedrus 23).

This paper treats two passages in Plato's Gorgias that appear to present two conflicting accounts of the art of rhetoric. In the first (463a6-465e1) Socrates describes rhetoric as a pseudo-art: a mere knack based on experience (ἐμπειρία) with no real knowledge of its subject-matter; it is a branch

of “flattery” (κολακεία) of the same status as cookery and cosmetics.

Plato's first treatment of rhetoric, almost entirely hostile, occurs in his Apology, the dramatic retelling of Socrates' trial and execution. Likely written between 390 and 399 BC (Kennedy 53), in the Apology Socrates chooses to die with plain truth rather than live thanks to excessive flourish.

The analogy to dialectic has important implications for the status of rhetoric. Plato argued in his Gorgias that rhetoric cannot be an art (technê), since it is not related to a definite subject, while real arts are defined by their specific subjects, as e.g. medicine or shoemaking are defined by their products, i.e., health and shoes. However, though dialectic has no definite subject, it is easy to see that it nevertheless rests on a method, because dialectic has to grasp the reason why ...

A philosophic rhetoric would be a discursive practice that seeks to shape or reshape the soul as an affective and endoxic entity. For Plato, the human soul is, in part, a rhetorical artifact. Any defense of justice that fails rhetorically to transform its audience's beliefs and desires necessarily fails as a genuinely persuasive defense.
